The Collections are double peer-reviewed conference proceedings published by ERI-BAS.

Copyright and Licensing:

The Author hereby assigns to ERI-BAS (the Publisher) the copyright in the Article and any supplemental tables, illustrations or other information submitted therewith that are intended for publication as a part of or as a supplement to the Article in all forms, throughout the world, in all languages, for the full term of copyright. The Author warrants that the Article is original work, has not been published previously and is not under consideration for publication elsewhere. The Article contains no libellous or unlawful statements and that it in no way infringes the rights of others. The Author guarantees that the Author is the owner of the Article and has full power to make this agreement.

Each conference proceedings in the series is committed to maintaining the highest ethical standards. Our ethic statements are based on COPE's Code of Conduct and Best Practice Guidelines for Journal Editors.

EDITORS

In order to provide the readers with conference proceedings of high quality, editors are guided by the following principles:

- The editor is responsible for maintaining the integrity of the academic record, for having processes in place to assure the quality of the material they publish and for precluding business needs from compromising intellectual and ethical standards.
- Editors' decisions to accept or reject a paper for publication should be based on the paper's importance, originality and clarity, and the study's validity and its relevance to the remit of the journal.
- The editor ensures that appropriate reviewers are selected for submissions (i.e. individuals who are able to judge the work and are free from disqualifying competing interests).
- The editor has systems in place to give authors the opportunity to make original research articles freely available.
- The editor has systems to ensure that material submitted to the proceedings remains confidential while under review.
- *ERI-BAS* employs the double peer review process.

REVIEWERS

- The reviewers of *the conference proceedings* assist the editors in taking the decision of publishing a submitted manuscript. By formulating suggestions to the authors, the reviewers can contribute to the improvement of submitted articles.

- Any manuscripts received for review must be treated as confidential documents. They must not be shown to or discussed with others except as authorized by the editor.
- Reviews should be conducted objectively. Personal criticism of the author is inappropriate. Reviewers should express their views clearly with supporting arguments.
- The reviewers should comment on the originality of submissions and should be alert to redundant publication and plagiarism.

AUTHORS

- The authors ensure that they have submitted original articles, and if the authors have used the work and/or words of others that this has been appropriately cited or quoted.
- Submitting the same manuscript to more than one source is considered as an unethical publishing behaviour and is unacceptable.
- Proper acknowledgement of the work of others must always be given. Authors should cite publications that have been influential in determining the nature of the reported article.

When an author finds error or inaccuracy in his/her own published article, it is the author's obligation to notify the proceedings editors and cooperate with them to retract or correct the paper.
